Processing of personal data means any operation or set of operations performed on your personal data, whether by automated or non-automated means, such as: collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, blocking, archiving, erasure or destruction of data.

In the context of the reservation and provision of services – in this case, registration for the conference – we may request certain personal data from you.

In this regard, AVE ACCOMODATION SRL may process, among others, the following personal data: surname, first name, telephone number, home address, email address, identity card series and number, passport series and number, Personal Numerical Code (CNP), company name (if applicable), VAT registration number (if applicable). These are necessary for the issuance of fiscal documents: invoice (invoice and receipt for cash payments) for participants in the event:

Data Subjects

The data subjects whose data may be processed by AVE ACCOMODATION SRL, exclusively for the purpose mentioned below, are you, in your capacity as a participant in the **10th International Conference on Advancements of Medicine and Health Care through Technology – MEDITECH 2026, 8–10 October 2026, Cluj-Napoca.**

For the purpose of fulfilling the legal obligations incumbent upon us.

AVE ACCOMODATION SRL will consider all information collected from you to be confidential and will not share it with third parties (except for the partners of the event: MEDITECH 2026).

Recipients of Your Personal Data

Recipients of the data means any natural or legal person, public authority, agency or other body to whom your personal data are disclosed, such as those specified below: AVE ACCOMODATION SRL in its capacity as the integrator of the MEDITECH 2026 event.

The confidentiality of personal data will be ensured by AVE ACCOMODATION SRL and the data will not be provided to any other third parties other than those mentioned in this document.

Duration of the Processing of Personal Data

For the purpose stated above, AVE ACCOMODATION SRL will process your personal data throughout the period during which AVE ACCOMODATION SRL carries out its activities, until you or your legal representative/authorized representative exercise your right to object/right to erasure (except where AVE ACCOMODATION SRL processes the data on the basis of a legal obligation or has a legitimate interest).

Following completion of the personal data processing operations for the purpose for which the data were collected, if you or your legal representative/authorized representative do not exercise your right to object/right to erasure, in accordance with the law, these data will be archived by AVE ACCOMODATION SRL for the period specified in AVE ACCOMODATION SRL's internal procedures and/or will be destroyed.

Rights of Data Subjects

In relation to AVE ACCOMODATION SRL, you have, in accordance with the applicable legal provisions, the following rights: the right to be informed, the right of access, the right to rectification, the right to erasure of data, the right to restriction of processing, the right to data portability, the right to object, and the right not to be subject to automated individual decision-making, including profiling.

The right to be informed means that you have the right to be informed about how your data are processed and the reason for the processing.

The right of access means that you have the right to obtain confirmation from us as to whether or not we process personal data concerning you and, if so, access to those data and to information regarding how the data are processed.

The right to object refers to your right to object to the processing of personal data when the processing is necessary for the performance of a task carried out in the public interest or when it concerns the legitimate interest of the controller. Where the processing of personal data is carried out for direct marketing purposes, you have the right to object to the processing at any time, free of charge and without providing any justification, by using, where applicable, the unsubscribe function included in the marketing materials.

The right to rectification refers to the correction, without undue delay, of inaccurate personal data. The rectification will be communicated to each recipient to whom the data have been disclosed, unless this proves impossible or involves disproportionate effort.

The right to erasure of data ("the right to be forgotten") means that you have the right to request that we erase your personal data, without undue delay, where one of the following grounds applies: the data are no longer necessary for the purposes for which they were collected or processed; you withdraw your consent and there is no other legal basis for the processing; you object to the processing and there are no overriding legitimate grounds; the personal data have been unlawfully processed; the personal data must be erased in order to comply with a legal obligation; the personal data have been collected in connection with the provision of information society services.

The right to restriction of processing may be exercised where the person contests the accuracy of the data, for a period enabling us to verify the accuracy of the data; the processing is unlawful and the person objects to the erasure of the personal data, requesting restriction instead; where AVE ACCOMODATION SRL no longer needs the personal data for processing purposes, but the person requires them for the establishment, exercise or defence of a legal claim; where the person has objected to the processing, for the period during which it is being verified whether the legitimate rights of the controller override those of the respective person.

You also have the right to lodge a complaint with a supervisory authority and to seek judicial remedy. For this purpose, in Romania, the supervisory authority is: www.dataprotection.ro
